



TERMINATION INSTRUCTIONS




STEP 1: FINISH THE LENGTH OF FIBER USING THE FF-STD-2-DP FINISHING TOOL



STEP 3: PLACE THE LC CONNECTOR INTO THE CRIMP TOOL JIG AND SLIGHTLY CLOSE THE JAW TO HOLD THE CONNECTOR IN PLACE



STEP 5: WHILE HOLDING THE FIBER IN PLACE, CRIMP THE END OF THE CONNECTOR



STEP 2: USING A STRIPPING TOOL, STRIP APPROXIMATELY 22.4mm (0.88 in) OF THE JACKET OFF OF THE END OF THE FIBER





STEP 4: SLIDE THE FINISHED PRE-STRIPPED FIBER INTO THE LC CONNECTOR UNTIL THE FIBER IS STOPPED BY THE POLISHED SET SCREWS NOTE: MAKE SURE BOTH FIBERS ARE MAKING CONTACT WITH THE SET SCREWS NOTE 2: PUSH LEVER FORWARD TO RELEASE RATCHET FOR THE JAWS



STEP 6: RELEASE THE CRIMPING TOOL AND THE FIBER REMAINS SECURE IN PLACE
